PRECAUTIONARY STATEMENTS

FIRST AID

GENERAL INFORMATION

TIGRIS Drift Control is an effective, easy to use, adjuvant for deposition improvement and drift retardation in spraying operations. **TIGRIS Drift Control** is compatible with most water soluble and wettable powder pesticides, desiccants, and cotton defoliant when applied by aerial or standard ground application.

ENVIRONMENTAL HAZARDS: Do not apply directly to water, or to areas where surface water is present, or to intertidal areas below the mean high water mark. Do not contaminate water when cleaning equipment or disposing of equipment wash waters. NOT FOR AQUATIC USE IN CALIFORNIA OR WASHINGTON STATE.

DIRECTIONS FOR USE

REFER TO PESTICIDE LABEL FOR SPECIFIC CROP USE AND APPLICATION RATES. Prior to use, read and follow all directions on this label and on the label of the pesticide being used. The pesticide manufacturer's label for specific usages and restrictions have precedence over DIRECTIONS FOR USE referred to on this label. Fill the spray tank half to three quarters full, add pesticide components, and provide good agitation. Shake **TIGRIS Drift Control** well before use. Select proper dosage from Dosage Chart and slowly add **TIGRIS Drift Control**. If additional surfactants or spray adjuvants are to be used, they should be added after **TIGRIS Drift Control**. Continue agitation until tank is full.

DOSAGE CHART

Spray Application	TIGRIS Drift Control per 100 gallons
Cone or Raindrop nozzles	1 - 3 fluid ounces
Flat Fan or Flood nozzles	1 - 5 fluid ounces
Off Center nozzles	2 - 6 fluid ounces
Spray Gun	5 - 8 fluid ounces

NOTE: The degree of drift hazard varies with the type of pesticide, application conditions, and vegetation near the sprayed area. Remember, pesticide drift is no accident. Common sense and sound application technology must be followed when spraying pesticides. **TIGRIS Drift Control** will retard, but not totally eliminate drift.
